**Purpose:** Provide effective teaching and learning to migratory students in small group and individual settings. Adjust instructional strategies and design to best fit the students unique needs and provide supplementary activities to support individual student learning.

### **Essential Functions:**

- Effective teaching and learning of the assigned subject(s) following the approved curriculum, instruction and assessment practices (district and/or program)
- Create and maintain a positive learning environment that includes active student participation and attention to each students' learning style
- Create, communicate and maintain classroom management practices that include student safety and effectively support students in the learning process

## **Additional Responsibilities:**

- Communicate with supervisor and, when applicable, team members to discuss progress and resolve any issues or concerns that arise
- Timely and effective communication with student/caregiver and Migrant Education Program staff
- Record and maintain accurate records, including attendance, progress and assessments
- Observe and respond appropriately to the needs and challenges of assigned students and promptly
  engage appropriate Migrant Program staff when a student may be at risk or in danger due to such
  issues as bullying, sexual harassment/misconduct, depression, lack of basic resources (clothing, food,
  care) or academic failure.
- Attend all meetings and trainings

### **Minimum Qualifications:**

- Working knowledge of assessing student needs, preparation of lesson plans, use of curriculum materials and evaluation instruments, and functioning effectively under the guidance of an instructional supervisor
- Demonstrated ability in academic subject areas to provide basic skills instruction, working with individual or small groups of students, maintenance of academic records, supplies and materials
- One (1) year of experience in an educational program, including the general supervision of children in structured activities designed to achieve instructional objectives via remediation and instruction
- Must have a reliable vehicle or reliable transportation (shared ride, public transportation) available to travel to assigned tutoring sites
